



## Terms and Conditions of Use

*The present document is important and affect your legal rights of using BMS. Your access to and use of the BMS Software is subject to the following terms and conditions and you agree to the terms and conditions below when you access and/or use BMS Software.*

1. Effectmakers grants you a limited, non-exclusive and non-perpetual right to access and use BMS Software for a maximum of two (2) month following the date when you first got access to BMS Software ("Evaluation Period") for free. After this period you are obliged to pay an agreed price pr. user pr. month as defined in the Price section on [www.effectmakers.com/software/pricing/](http://www.effectmakers.com/software/pricing/), or as agreed by you and Effectmakers, to continue using the software. Any rights not explicitly granted herein are reserved by Effectmakers.

2. You may access and use BMS Software for your own internal purpose. You may not let any third-party access or use BMS Software.

3. Save as otherwise provided for by mandatory law, you may not decompile, reverse engineer or disassemble the BMS Software and/or create any competitive or derivative products of the BMS Software.

4. During the Evaluation Period, you may contact Effectmakers to obtain support in connection with your access to and use of BMS Software. Effectmakers will - to the extent deemed commercially reasonable including the availability of resources (to be decided in the sole discretion of Effectmakers) - answer such support requests when deemed possible by Effectmakers. Effectmakers, however, undertakes no obligations in terms of support including without limitation related to response times or responses related to such support requests.

After you trial end and when your start paying for the use of the software, you will be entitled to receive support as described on [www.effectmakers.com/software/implementation/](http://www.effectmakers.com/software/implementation/) or as agreed by you and Effectmakers.

5. Your access and use rights will terminate automatically and without separate notice upon expiration of the Evaluation Period and you agree that Effectmakers may discontinue your access to the BMS Software without notice upon expiration of the Evaluation Period. Unless, an agreement between the two parties take place with a purchase of a commercial license of BMS Software during the Evaluation Period or at the expiration date.

6. Any data that you process using BMS Software during the Evaluation Period will be permanently lost, unless you pay for a commercial license of BMS Software prior to the expiration of the Evaluation Period or make agreement with Effectmakers.

7. BMS Software is made available "as-is" and Effectmakers disclaims any and all warranties, liabilities, damages and any other claims from you irrespective of the basis hereof related to your access or inability to access, use or inability to use and/or the results of your use of BMS Software.

8. The parties agree to maintain in confidence any information received from the other party which is designated as "confidential" or should be treated as confidential given the nature of such information.

9. You agree that Effectmakers may contact you by e-mail and/or telephone during the Evaluation Period and after the expiration of the period for purposes related to your experiences using the BMS Software, your acquisition of a commercial license and other matters pertaining to marketing and sales of BMS Software etc.

10. This agreement is governed by Danish law and shall be subject to the exclusive jurisdiction of the Danish courts.

11. All Confidential Information shall be kept mutual strictly confidential and shall not be disclosed in whole or partially to any 3rd party. Confidential Information" means:

a) all information (whether written, oral or in any other form) supplied to Effectmakers Aps, as well as,

b) information regarding BMS programming, roadmaps or technical insight gained during the evaluation, use and/or implementation.
