Importing transactional data

Importing transactional data in BMS is an option that offers a fast way to load data.

In order to perform the procedure, it is important to keep the file formats in mind. An eventual file must be built up from six columns: Accounting date, Account name, Item number, Customer number, Amount, Units.

The following describes the steps of importing transactional data.

How to import transactional data

Data tab

Go to the top ribbon and select the Data tab.



Open Import

There are two different imports you can do: Actual Sales scenario and Other Costs into the Forecast scenario.

A new window will open for the Import.



Browse for the file

Click on Browse to view the files uploaded to the server.



Select the file you want to import. You can only select one file at a time. The file is automatically loaded in the window. $${\ }^{\rm Name}$$




5 Import options

In the Source file template you find the Options field with some options of configuring the file you want to import. The options available are:

- File contains values in [Packages]: This option makes BMS aware that the units in the file are entered in packages and not SKUs.
- Delete existing data: This options deletes the existing data in BMS. The function deletes data concerning the item numbers and customer numbers, but only in the time period of the data file. The time period of the data file is defined as: from the first Accounting date to the last.
- Data starts on row #: A simple specification of where the data starts in the file.

Below the Options, you have the Preview field, where you can see all changes you make in Options.

If Errors or Warnings appear in this field, you will not be able to complete importing. They are arranged in order to prevent you from importing incorrect data. This means that you have to work carefully with the mappings, so you can be accurate with the data you import in BMS.



The button Import will only be active in the Import template.

In the window Import products you can go to the template Import in order to see the Analysis of file. In this field you can see the results of the import and if there are any errors in the data.
